Nancy Guillory Award

The Nancy Guillory award is awarded each spring at the annual meeting to a mental health professional who has made a substantial impact on the lives of children and who has been instrumental in the promotion of play therapy. Nominations are member submitted and committee reviewed.

This award honors the memory of a graduate student who was completing her work in counseling and play therapy at the time of her death.

This year's recipient of the Nancy Guillory Award was Kelly Webb Ferebee of the North Texas Chapter for Play Therapy.

Dr. Ferebee was nominated for her years of service and dedication to the promotion and advancement of the field of play therapy. Particularly, Kelly has worked

Advocacy Day at the Capitol: Legislative Session 2009-2010

This year Advocacy Day is scheduled for May 5th, 2009 at the Capital Building in Austin Texas.

Hot topics on the Public Policy Agenda are as follows:

School Counselor Issues

- Senate Bill 568 would mandate schools to notify parents when a the school does not have a counselor on staff.

- House Bill 3 would support the counselor's role in actual counseling duties and limit the amount of time spent conducting testing duties.

Licensed Professional Counselor Issues

- HB 4401 would reduce archaic language and would not allow insurance companies to require a physicians order for a client to be seen by an LPC.
